Directions: Riding Right Farm is located at the intersection of County Routes 59 and 59A in the Washington County town of Cambridge approximately 2 miles off State Route 67.

Points South: To use the Buskirk Covered Bridge take Route 67 east from Schaghticoke to Buskirk. Left onto 103, cross covered bridge, take left onto 59. Farm is 1.5 miles on right. Option: Route 67 east from Schaghticoke Fair. Third left onto 114, will become 74 at County line. Turn right onto 59A at the Pleasant Valley Grange in South Cambridge. Farm is 1 mile on left.

Points East: Route 22 to Eagle Bridge, West on Route 67 to Buskirk. Right onto 103. Cross Covered bridge. Left on 59. Farm is 1.5 miles on right.

Points North & West: Route 74 south from Greenwich to South Cambridge, Left on 59A for 1 mile. Farm is on left.
